## Description

Provide a short description of the event and its activities.

The interviewers conducted structured in person consultations interviews with 284 people with permanent residence in Poland. Each interview took approximately 30 minutes and concerned interviewees' attitudes towards climate change related issues as well as their behaviour regarding carbon footprint. These consultations were in one-on-one format and pre-defined across the entire Consortium in order to

provide a good basis for comparative analysis that shall serve for other events already in the beginning of 2025.

10 sections of the consultation questions covered the likelihood and impacts of future actions such as reducing waste in various ways, using public transport and other alternatives instead of a car/ flying, investing in lowering the energy consumption of housing, reducing meat from diet. The interviews also focus on the conditions of buildings respondents live in, public transportation, active mobility, use of electric cars and government's incentives.

Respondents were provided a space to ask questions related to the topic, that shall be responded by the JustGreen project policy analysts and published on the website and social media pages, and shall be used in policy analysis.

These questions mainly focused on the costs of charging a car batteries and its effect on the environment as compared to the internal combustion engine, disposal of batteries and overall effect of the Green Deal and available initiatives in the rest of the world.

Furthermore, national studies and analysis of the data obtained via this citizens' consultations shall be finalized on 15.12.2024, and comparative analysis of all countries shall follow. This way data analysis shall be used not only for policy analysis, but also for the activities within WP6 Webinars Comparing Outputs from Consultations and Focus Groups and WP7 Roundtable for Journalists, and other WPs such as WP9-11 Climate Assemblies.
